DECISION WAPP/78/DEC.03/11/17

**RELATING TO THE APPLICATION FOR MEMBERSHIP OF SUNON ASOGLI
POWER (GHANA) LIMITED INTO THE WEST AFRICAN POWER POOL (WAPP)**

The General Assembly

CONSIDERING the Decision A/DEC.5/12/99 of the twenty-second summit of the Authority of the Heads of State and Government of ECOWAS held in Lomé on December 10th, 1999 relating to the establishment of the West African Power Pool (WAPP);

CONSIDERING the Decision A/DEC.18/01/06 of the twenty-ninth summit of the Authority of Heads of State and Government of ECOWAS held in Niamey on January 12th, 2006, relating to the adoption of Articles of Agreement for the establishment and functioning of the WAPP;

CONSIDERING the Decision A/DEC.20/01/06 of the twenty-ninth summit of the Authority of Heads of State and Government held in Niamey on January 12th, 2006, relating to the establishment of the WAPP Secretariat as a specialized institution of ECOWAS;

RECALLING the Headquarters Agreement signed between the Republic of Benin and the West African Power Pool Secretariat;

CONSIDERING the stipulations in the Articles of Agreement relating to the organisation and functions of the West African Power Pool dated July 6th, 2006 in particular Articles 1,4, 5, 7, 9 and 26;

CONSIDERING the Decision WAPP/72/DEC.11/11/16 of the eleventh session of the General Assembly of WAPP in Ouagadougou on November 11th, 2016, relating to the adoption of the conditions and modalities of enrolment into the WAPP;


NOTING the letters relating to the application for WAPP Membership from Sunon Asogli Power (Ghana) Limited, and dated August 29th and 30th, 2017, backed with a company profile, a Registration Certificate, two Provisional Licenses for Wholesale Electricity Supply and Electricity Export, a Recommendation Letter from Ghana Grid Company (GRIDCo) , and a formal commitment to pay their contribution as well;

CONSIDERING the Resolution WAPP/235/RES.14/10/17 of the thirty-sixth meeting of the WAPP Executive Board held in Cotonou on October 14th, 2017, relating to the application for membership of Sunon Asogli Power (Ghana) Limited into the West African Power Pool.

DECIDE:

- Article 1:** Sunon Asogli Power (Ghana) Limited is accepted as a member of WAPP.
- Article 2:** The Secretary General shall take all necessary measures to ensure the implementation of this Decision.
- Article 3:** The present Decision comes into effect upon its signature.
