# DECISION WAPP/79/DEC.03/11/17 ADOPTING THE ACTIVITY REPORT OF THE SECRETARY GENERAL FOR THE PERIOD FROM NOVEMBER 2016 TO OCTOBER 2017

### The General Assembly

**CONSIDERING** the Decision A/DEC.5/12/99 of the twenty-second summit of the Authority of the Heads of State and Government of ECOWAS held in Lomé on December 10<sup>th</sup>, 1999 relating to the establishment of the West African Power Pool (WAPP);

**CONSIDERING** the Decision A/DEC.18/01/06 of the twenty-ninth summit of the Authority of Heads of State and Government of ECOWAS held in Niamey on January 12<sup>th</sup>, 2006, relating to the adoption of Articles of Agreement for the establishment and functioning of the WAPP;

**CONSIDERING** the Decision A/DEC.20/01/06 of the twenty-ninth summit of the Authority of Heads of State and Government held in Niamey on January 12<sup>th</sup>, 2006, relating to the establishment of the WAPP Secretariat as a specialized institution of ECOWAS;

**RECALLING** the Headquarters Agreement signed between the Republic of Benin and the West African Power Pool Secretariat;

**CONSIDERING** the stipulations in the Articles of Agreement relating to the organisation and functions of the West African Power Pool dated July 6<sup>th</sup>, 2006 in particular Articles 1, 4, 5, 7, 11, 12, 14 and 26;

**CONSIDERING** the Decision WAPP/65/DEC.25/11/15 of the tenth session of the General Assembly of WAPP held in Dakar on November 25<sup>th</sup>, 2015 adopting the 2016-2019 WAPP Business Plan;

**CONSIDERING** the Resolution WAPP/208/RES.24/10/16 of the thirty-second meeting of the Executive Board of WAPP held in Cotonou on October 24<sup>th</sup>, 2016, relating to the adoption of the 2017 Work Program and Associated Budget for the WAPP;

**CONSIDERING** the Resolution WAPP/238/RES.2/11/17 of the thirty-seventh meeting of the Executive Board of WAPP held in Accra on November 2<sup>nd</sup>, 2017, relating to the adoption of the Activity Report of the Secretary General for the period from November 2016 to October 2017.

#### DECIDE:

- Article 1: The Activity Report of the Secretary General for the period from November 2016 to October 2017 is adopted.
- **Article 2:** The Secretary General shall take all necessary measures to ensure the implementation of this Decision.
- Article 3: The present Decision comes into effect upon its signature.
