**DECISION WAPP/70/DEC.11/11/16 ADOPTING THE ACTIVITY REPORT OF
THE SECRETARY GENERAL FOR THE PERIOD FROM NOVEMBER 2015 TO
OCTOBER 2016**

The General Assembly

CONSIDERING the Decision A/DEC.5/12/99 of the twenty-second summit of the Authority of the Heads of State and Government of ECOWAS held in Lomé on December 10th, 1999, relating to the establishment of the West African Power Pool (WAPP);

CONSIDERING the Decision A/DEC. 18/01/06 of the twenty-ninth summit of the Authority of Heads of State and Government in Niamey on January 12th, 2006, relating to the adoption of Articles of Agreement for the establishment and functioning of the WAPP;

CONSIDERING the Decision A/DEC. 20/01/06 of the twenty-ninth summit of the Authority of Heads of State and Government in Niamey on January 12th, 2006, relating to the establishment of the WAPP General Secretariat as a specialized institution of ECOWAS;

RECALLING the Headquarters Agreement signed between the Republic of Benin and the WAPP Secretariat;

CONSIDERING the stipulations in the Articles of Agreement relating to the organisation and functions of the WAPP dated July 6th, 2006, in particular Articles 1, 4, 5, 7, 11, 12, 14 and 26;

CONSIDERING the Resolution WAPP/191/RES.30/10/15 of the 29th meeting of the Executive Board of WAPP held in Cotonou on October 30th, 2015, adopting the 2016 Work Program and Associated Budget for the WAPP;

CONSIDERING the Decision WAPP/65/DEC.25/11/15 of the Tenth meeting of the General Assembly of WAPP held in Dakar on November 25th, 2015 adopting the 2016-2019 WAPP Business Plan;

CONSIDERING the Resolution WAPP/214/RES.09/11/16 of the thirty-third meeting of the Executive Board of WAPP held in Ouagadougou on November 9th, 2016, adopting the activity report of the Secretary General for the period November 2015 to October 2016.

DECIDE:

- Article 1:** The Activity Report of the Secretary General for the period from November 2015 to October 2016 is adopted.
- Article 2:** The present Decision comes into effect upon its signature.
- Article 3:** The Secretary General shall take all necessary measures to ensure the Implementation of this Decision.
