DECISION WAPP/67/DEC.25/11/15 RELATING TO THE APPOINTMENT OF THE CHAIRPERSON OF THE WEST AFRICAN POWER POOL EXECUTIVE BOARD

## The General Assembly

CONSIDERING the Decision A/DEC.5/12/99 of the twenty-second summit of the Authority of the Heads of States and Governments of ECOWAS held in Lomé on December 10, 1999 relating to the establishment of the West African Power Pool (WAPP);

**CONSIDERING** the Decision A/DEC. 18/01/06 of the twenty-ninth summit of the Authority of Heads of State and Government of ECOWAS held in Niamey on January 12, 2006, relating to the adoption of Articles of Agreement for the establishment and functioning of the WAPP;

**CONSIDERING** the Decision A/DEC. 20/01/06 of the twenty-ninth summit of the Authority of Heads of State and Government in Niamey on January 12, 2006, relating to the establishment of the WAPP Secretariat as a specialized institution of ECOWAS.

**RECALLING** the Headquarters Agreement signed between the Republic of Benin and the West African Power Pool Secretariat;

CONSIDERING the stipulations in the Articles of Agreement relating to the organisation and functions of the West African Power Pool dated July 6<sup>th</sup>, 2006 in particular Articles 1, 4, 5, 7 and 26;

**CONSIDERING** the Decision WAPP/15/DEC.26/10/07 of the second session of the General Assembly of WAPP held in Abuja on October 26<sup>th</sup>, 2007, relating to amendment of WAPP membership criteria;

**CONSIDERING** the Resolution WAPP/72/RES.28/10/09 of the tenth meeting of the Executive Board of WAPP held in Accra on October 28<sup>th</sup>, 2006, relating to the renewal of tenure of the Chairperson and Vice-Chairperson of the WAPP Executive Board;

CONSIDERING the Decision WAPP/33/DEC.29/10/09 of the fourth Session of the General Assembly of WAPP held in Accra on October 29<sup>th</sup>, 2009, relating to the renewal of tenure of the Chairperson and Vice Chairperson of WAPP Executive Board;

**CONSIDERING** the Resolution WAPP/198/RES.30/10/15 of the twenty-ninth meeting of the Executive Board of WAPP held in Cotonou on October30<sup>th</sup>, 2015, relating to the appointment of the Chairperson of the West African Power Pool Executive Board.

## DECIDE:

- Article 1: The appointment of Engr. (Dr.) Abubakar T. ATIKU as Chairperson of the WAPP Executive Board is approved for a tenure of three (3) years, covering the period from the 10<sup>th</sup> Session of the General Assembly to the 13<sup>th</sup> Session of the General Assembly.
- Article 2: The present Decision comes into effect upon its signature.
- Article 3: The Secretary General shall take all necessary measures to ensure the implementation of this Decision.
