**RESOLUTION N°015/ERERA/20**  
**on the amendment of the procedure of application for admission in the**  
**Regional Electricity Market approved by Resolution N° 013/ERERA/18**

The Regulatory Council,

**MINDFUL** of the Supplementary Act A/SA.2/01/08 establishing the ECOWAS Regional Electricity Regulatory Authority (ERERA);

**MINDFUL** of Regulation C/REG.27/12/07 of 15 December 2007 as amended, concerning the Composition, Organization, Functions and Operation of ERERA;

**MINDFUL** of the Directive C/DIR.1/06/13 dated 21 June 2013 on the organization of the regional electricity market;

**MINDFUL** of the Resolution N°005/ERERA/15 dated 18 August 2015 approving the Regional Market Rules for the West African Power Pool (WAPP) notably its articles 27 and 28;

**MINDFUL** of the Resolution N°012/ERERA/18 dated 22 June 2018 on the effective date of the Regional Market Rules for the West African Power Pool;

**MINDFUL** the Resolution N° 013/ERERA/18 dated 19 October 2018 approving the procedure of application for admission in the Regional Electricity Market;

**DESIRING** to correct the inconsistency and inaccuracy appearing with regard to the requirements relating to the submission of an application for admission to the Regional Electricity Market;

**RESOLVE THAT:**

1. The procedure of application for admission in the Regional Electricity Market approved by Resolution N° 013/ERERA/18 is hereby amended as follows:

In place of:

*"3. Submission of application*

*Any person wishing to apply for participation in the Regional Electricity Market must:*

- (a) Submit evidence of meeting the participation qualifications;
- (b) Complete the market participant application form;
- (c) Attach to the application form, a copy of market license issued by the ECOWAS Regional Electricity Regulatory Authority (ERERA);
- (d) Attach to the application form, a signed copy of Market Participation Agreement".

Read instead:

"3. Submission of application


Any person wishing to apply for participation in the Regional Electricity Market must:

- (a) Submit evidence of meeting the participation qualifications;
- (b) Complete the market participant application form;
- (c) Attach to the application form, a copy of Market Participation Agreement signed by the applicant."

- 2. The other provisions remain unchanged.
- 3. The procedure of application for admission in the Regional Electricity Market thus amended, shall be published in the ERERA official Bulletin and Website.


