
After review of the documents submitted by the WAPP,



PROCEDURE OF APPLICATION FOR ADMISSION IN THE REGIONAL ELECTRICITY MARKET

1. Objective of the procedure

The Procedure of Application for Admission in the Regional Electricity Market is developed in accordance with Article 27, "Admission of Market participant" of the Regional Market Rules (RMR) for applying for admission to the Regional Electricity Market.

All Applicants must familiarize themselves with these rules before registering. The Applicant shall read and understand the Regional Market Rules, the Operations Manual, the ECOWAS Regional Electricity Market Procedures and all associated documentation and procedures.

The market participant application form, here attached in Annex I, shall be used for applying for admission to the ECOWAS Regional Electricity Market.

The Market Participation Agreement, here attached in Annex II, shall be executed by the Applicant while submitting it Application.

2. Participation Qualifications

Becoming a Market Participant in the West African Power Pool (WAPP) is voluntary and is open to any entity, public or private, which meets the minimum criteria for admission of a Market Participant as defined in Article 8 and 9 of the ECOWAS Regional Electricity Market Procedures for the corresponding market Phase.

3. Submission of application

Any person wishing to apply for participation in the Regional Electricity Market must:

- (a) Submit evidence of meeting the participation qualifications;
- (b) Complete the Regional Electricity Market participant application form ;
- (c) Attach to the application form, a copy of market license issued by the ECOWAS Regional Electricity Regulatory Authority (ERERA);
- (d) Attach to the application form, a signed copy of Market Participation Agreement.

4. Processing of application

- (a) The whole process time of the application is within sixty (60) days of the receipt of the complete application.
- (b) On receipt of the application, the System and Market Operator (SMO) will issue letter of receipt if the application is complete.
- (c) The SMO will review the application within 30 days of the receipt of the application

- (d) Successfully reviewed application, with recommendation, will be submitted by the SMO to ERERA for approval.
- (e) If within twenty (20) days of the receipt of the reviewed application, the approval of ERERA is not notified to the SMO, then the application is deemed to be approved as recommended.
- (f) After ERERA approval, within 5 days, the SMO shall register and issue a unique identification number to the applicant as Participant at the Regional Electricity Market.
- (g) Notification will be issued by the SMO to the applicant within five (5) days after the registration, and the applicant will be considered admitted at the date of notification.
